The seminar will take place in Sallanches (FRA) from 28 to 30 March 2025. The schedule is

- Sunday 30 March - exam, lunch and departure of participants. The seminar should end at 16:00, please do not arrange a flight before 19:00 on 30 March

To be eligible to participate at the seminar, candidates must conform to the current regulations as laid down in the Term of Reference for WAE Continental Judges published on the WAE Website. In particular we draw your attention to the limit of Judges per country.

Candidates will also need to pass a pre-seminar test that will be sent shortly after registration. The result of this test will be communicated as soon as the test is corrected.

The seminar language will be English; candidates must be able to read, understand and have a fair writing level in this language.

Subject to the premises capacity, sit-ins may be accepted. Those interested should contact the organiser directly (information below).
