## IMPORTANT INFORMATION

### Dates and Location

The Archery European 3D Championships will take place in Lake Of Baratz, in the territory of Sassari, Sardinia, and will be organized by the Archery Club Torres Sassari, from 4<sup>th</sup> to 10<sup>th</sup> October 2010.

Sassari is the second biggest city in Sardinia, the beautiful and interesting island in the Mediterranean Sea, very well known around the world for its astonishing beaches and ancient history.

The elimination round will be held beside the Lake of Baratz, the only natural closed lake in Sardinia, that is about 10 Km from the Hotel.

The semi finals and the finals will be held beside the city park of the city of Sassari.



The Lake of Baratz, the only natural closed lake in Sardinia, is the place where the qualifications will be held; the lake is only fed by underground sources and around its shores it is possible to watch a lot of peculiar wild birds, flowers and plants.

The field of the competition for the Finals is Baddimanna: this is a park in the city of Sassari; it is in the centre of the city and it is an attractive place for young people and children.

Sassari is easily reached by plane; the “Riviera del Corallo” airport in Alghero has daily connections to the major Italian cities such as Rome and Milan, and from there daily connections to the major European airports.

Such an airport is just 10 km far from Alghero, and there is a bus shuttle service for transfers.

“Riviera del Corallo” airport also has daily connections to England, Spain and Germany, by Ryanair flight Company.

The international airport “Olbia - Costa Smeralda” is about 100 km from Sassari ;

Cagliari is about 240 Km., and it is also daily connected to the major European destinations;

Sardegna is also reachable by ferryboat with some Ferry Companies which offer connections from/to Civitavecchia, Genova and Livorno.

4. I promise to abide by all EMAU rules, regulations, decisions and rulings, including without limitation all those relating to doping or use of drugs. An intention to appeal when it might affect the progression of an athlete from one stage of the competition to the next, must be expressed in writing and lodged with the Chairperson of the Tournament Judge Commission and/or the Jury within 5 minutes of the end of the relevant round or match, whichever comes first. The written appeal must be lodged with the Jury within 15 minutes of the end of the relevant round or match, whichever comes first, to allow the Jury to come to a decision before the beginning of the next round of the competition.
