Dear Presidents,

As you know, during the European Outdoor Championship in Vittel (France), also the EMAU Congress will take place. The date of the Congress is 12<sup>th</sup> May at 9 o'clock.

As outlined in our Constitution and Rules, we inform you that Mr.Vladimir Esheev, vice president, Mrs Eva Thesen and Mr Lorenzo Miret Alfonso, Council members, finish their terms in 2008.

The following positions are vacant or up for re-election:

Vice President (1) Council Members (2)

Furthermore EMAU Council will submit a motion to the Congress to increase the number of Council members by 2 members. If this motion passes, the new 2 members will be elected during the Congress. In this case the Council members to be elected will be 4.

Also the following EMAU Committees must be elected:

DTAC Committee (3 positions)
Judges Committee (3 positions)
Junior Development Committee (3 positions)

Also in this case EMAU Council will submit a motion to the Congress for the installation of a 3D/Field Committee composed by 3 members. If this motion passes, the new Committee members will be elected during the Congress.

The Members Associations are invited to submit candidatures for the positions as mentioned above to the EMAU Secretary General (via Vitorchiano 113 – 00189 Roma, Italy- Fax 0039 06 36856653 – Email media@fitarco-italia.org) not later than **12 April 2008.** As you know nominations can only be submitted by the Federations.

Furthermore, as we informed you on November 15 2007, with a letter Ref.n. 103, each Member Association can submit to Congress motions for the Constitution and modifications for the Rules. The deadline for the motions which must be sent to the Secretary General , as mentioned above, is **February 10 2008**
