Dear President,

I would like to inform you about some decisions taken by the EMAU Council, during the meeting held on 22 November in Rome.

European Championships

- The 12th European Indoor Championship will be held in Porec from 16 to 21 March 2010. The Council appointed Mrs Evelyn Papadopoulou (GRE) as EMAU Technical Delegate.
- The 2nd edition of the European Clubteams Cup will take place in Madrid from 9 to 11 October 2009. The Council appointed Mr Patrick Lebeau (FRA) as TD and made some changes in the Rules.

The first edition, held this year in Moliet (FRA), was a great success with the participation of 26 men and 19 women teams.

1. Type of the competition

- Outdoor Target archery 70 M rounds
- The competition includes a qualification round (2x70m) according to the FITA rules, for the team ranking, followed by the Team-matches as per article nr . 5
- The procedure of the team event will take place on the principle of flights (see following rules). Each match is shot according to the FITA rules.
- Recurve Division only.
- Separate men and women events.
- Each clubteam is composed of 3 archers (each archer of the team has to belong to the same club).
- The 16 first men clubteams and the 16 first women club-teams teams from the qualification round are qualified for the Team-matches.
 The ranking of the teams is obtained by adding the scores of the 3 archers of the clubteam at the end of the qualification round.
- If less than 16 clubteams take part in a category, only the first 8 clubteams of the qualification round, qualify for the match-event.
 The other clubteams (ranked from the 9th to the 15th place) will compete in a "secondary round". They shoot at the same time as the team-matches.
- A floating trophy, offered by EMAU (one for men, one for women) will be issued every year.
 The winning teams will be in charge of the engraving of the trophies.
 The clubteam which wins the trophy 3 times in a row, may keep the floating trophy permanently and a new trophy will be arranged by EMAU.

2. Selection of clubteams

- The EMAU Member Association takes care of its Federation's clubteam-participation.
- Number maximum of clubteams by country:
 5 men clubteams and 5 women clubteams.
- A Club can participate with only one team men and one team women
- One clubteam is composed of 3 archers.
 The members of the team must have all the same nationality which is that of the Member Association of which the Club is member.
- If there is a full selection there are 30 archers for one country.
 5 women clubteams and 5 men clubteams. Mixed teams are not accepted.
- The participating clubteams must be officially recognized by their Federation, according to their National Rules.
- Before being allowed to participate in the European Clubteams Cup, the Federation
 must confirm that the clubteam-athletes are members of the participating club as per
 the 1st January of that year.

3. Selection of the organizer

- Each year in July (Y) EMAU asks the EMAU Member Associations for bids for the organization of the European Clubteams Cup for the year (Y+1) and EMAU-council allocates the event for the year (Y+1).
- Deadline for such application is 31st October of the year (Y).
- The national federation selects the club who are organized the competition.

4. Program / Schedule

- The competition duration is 2 days.The competition is proposed to be organized on September or October

5. Rules

- All members of a team have to wear the same uniform.
- If a team arrived with more than 3 archers, they must communicate to the TD the names of the 3 archers composing the team before the end of the practice Session on Friday.
- The 3 archers of a team that shoot in the Qualification Round, have to shoot the team matches on Sunday. There is not possibility to change an archer during the competition.
- At the end of the individual qualification ranking round, the first 16 teams (men and women) are entered into 4 groups of 4 teams, according to the following scheme:

In each group each team competes against the three others in the group.
 At the end of these 3 matches, a ranking in each group is established by the allocation of following points :

At this stage of the competition, all the teams have shot three matches.

Handling of ties:

• Tie at the end of a match:

shoot-off according to the FITA rules

• After the 3 group matches:

the total score of the 3 team-matches decides the tie The scores of possible shoot off to decide one match will not take in count for this total.

• when there is still a tie: shoot-off according to the FITA rules

After the groups' matches, this is the situation:

* After the group-matches rounds, the first 8 teams (when there are 16 teams participating) or the first 4 teams (participation of 8 teams) will be allocated 1 extra point.

Ranking matches: 2 matches for all teams.

• Match 1: the teams at the same rank in the 4 groups meet to establish their final ranking:

teams of group nr. 1 meet the teams of the group 4 teams of group nr. 2 meet the teams of the group 3

• Match 2: the winners and the losers of the first match shoot against each other. If the timing allows it, the two winners amongst the 1st of match nr. 1, can shoot their (final) match separately, otherwise all teams shoot together.

6. Yearly planning:

July	EMAU writes to the Federations and asks for bids from organizers for the event for the following year
31 st of October	deadline for bids to be received by EMAU for the coming year
November	EMAU council decides on the bids and EMAU publishes the decision on the EMAU Website.
5 months before the event	The organizer send to EMAU all the information about (inscription, transport, hotel).
90 days before the event	 EMAU MAS send the club-entries to the organizer together with the confirmation that a) the Clubs are members of the EMAU MAS and b) the archers are members of the participating club (article 2)
30 days before the event	Payment to be made as per the information in the invitation

7. Appointment of Judges Judges-accommodation- and -travel-costs

- Number of judges 8 National and 2 Continental Judges.
- The host country carries the accommodation costs of all judges.(8+2)
- The host country will appoint 8 National Judges .
- EMAU will appoint 2 Continental Judges and carries their travel cost.

8. Entry fees

- EMAU council decides on the level of the entry fee (max Euro 150.-. /clubteam).
- The participating Clubteams have to pay the entry fee and all the accommodationfees as per the invitation-information, to the Organizing Committee 30 days before the competition (see article 6).


9. The field of play for the European Clubteams Cup

There will be 2 teams in a lane of 5 m. In this case, 16 lanes of 5 m are necessary which means: 80 m minimum.

It might be necessary to have some what smaller lanes when the FOP does not allow for 5 m. wide lanes.

The position of the judges must be discussed as per the availabilities on the FOP's.

RULES OF THE EUROPEAN JUNIOR CUP COMPETITIONS 2009

1 The European Junior (and Cadet) Cup competitions are organized in accordance with FITA Constitution and Rules (FITA C&R).

2 **European Junior Cup competitions – General Format:**

- 2.1 There will be:
 - Two legs of the European Junior Cups and Junior Cup Final during European and • Mediterranean Junior Archery Championships in even years;
 - One leg of the European Junior Cup and Junior Cup Final in odd years (when • FITA World Junior Archery Championships is organized).
- 2.2 Daily Schedule of the European Junior Cup competitions (including official training day, last day of the competition - Saturday) will be prepared by the organizers together with the appointed Technical Delegate:

Ranking Round – FITA Round – 5 days: Tuesday – Saturday Ranking Round – 70m/60m Round – 4 days: Wednesday - Saturday

2.3 **Allocation of European Junior Cup competitions**

- Any organization willing to host Junior Cup event according to EMAU requirements 2.3.1 can submit a bid to EMAU Secretary General through the Member Association (MA) of the country in which the Junior Cup event will take place.
- 2.3.2 The bid must be submitted before June 30 of the year previous to the year of event. After receiving the bid the EMAU Secretary General will send to the organizers willing to organize Junior Cup event the EMAU Events Evaluation Checklist to fulfil.
- 2.3.3 The international competition calendar and the school calendar in Europe have to be taken into account. However Junior Cup tournaments should be organized:

 1^{st} leg around the 3^{rd} week of May 2^{nd} leg around the 3^{rd} week of July

- 2.3.4 The Calendar of Junior Cup competitions for each year will be approved by EMAU Council and published at the official web site. (Appendix 1)
- 2.4 **Disciplines** (from art 4.1 FITA C&R)
- 2.4.1 The European Junior Cup competitions are organized in discipline of Outdoor Target Archery.

- **2.5 Classes admitted** (from article 4.2 FITA C&R):
 - Cadet Women
 - Cadet Men
 - Junior Women
 - Junior Men

2.6 Divisions admitted (from article 4.3 FITA C&R)

- Recurve Division as specified in article 7.3.1 of FITA C&R;
- Compound Division with equipment as specified in article 7.3.3 of FITA C&R.
- 2.7 All FITA MAs are eligible to compete in European Junior Cup competitions, but only the results of the athletes from EMAU MA's will be taken for the Junior Cup Circuit.

2.8 Rounds shot at European Junior Cup competitions

- Outdoor Target archery rounds (according to art. 4.5.1 FITA C&R)
- 2.8.1 The FITA Outdoor Target Archery Round (according to art. 4.5.1.2 FITA C&R) will be shot in odd years;
- 2.8.2 The FITA 60 Meter Round (according to art. 4.5.1.6 FITA C&R) and the FITA 70 Meter Round (according to art. 4.5.1.7 FITA C&R) will be shot in even years.

3 Application of FITA rules at European Junior Cup competitions

- 3.1 The Outdoor Target Archery rules will comply with those of FITA, which are in force in the year of the organisation of the European Junior Cup competition.
- 3.2 The articles of the FITA rules below are applied at Junior Cup competitions with following exceptions:
- 3.2.1 The maximum of 64 archers per category will qualify for the Olympic Round Individual event.
- 3.2.2 Archers both in the individual and team Final rounds may continue to score and collect their arrows.
- 3.2.3.1 The quarter and semi-finals matches may be shot not alternating.
- 3.2.3.2 The final matches for the Bronze and Gold Medals will follow the FITA ruling of alternate shooting. At this stage of the event two targets will be utilised for each match (*i.e. one archer per target*).

- 3.2.3.3 If the time frame of the competition doesn't allow to fit required number of alternated matches, the matches can be combined. The sufficient number of judges with stopwatches will be provided.
- 3.2.3.3.1 All bronze medal matches may be shot at the same time.
- 3.2.3.3.2 All Cadet gold medal matches may be shot at the same time
- 3.2.3.3.3 All Junior gold medal matches may be shot at the same time.
- 3.2.4 Team competitions
- 3.2.4.1 The number of athletes that may be entered by a MA is limited. At European Junior Cup competitions, a MA may enter no more than four (4) athletes in each category.
- 3.2.4.2 When the MA will enter 4 athletes in one category, the team will consist of three (3) athletes only. All members of a team must be announced prior to the start of the Qualification Round. Such members must take part in the Qualification Round and cannot be changed.

4 Awards at European Junior Cup competitions:

- 4.1 The top 3 placed individuals and teams in each division and in each class in Olympic rounds in each leg of the European Junior Cup competition will receive awards as the winners of that tournament.
- 4.2 The awards at the European Junior Cup competitions (except European & Mediterranean Junior and Cadet Championships) will be provided by the Organizing Committee (8x3 for individuals and 24x3 for teams).
- 4.3 At the Awards Ceremony the Anthem of the Individual and Team winner's country will be played, the flags of the top three placed individuals' and teams' countries will be raised.

5 Determining the winners of the European Junior Cup circuit:

5.1 Determining the winners in the Individual competition

5.1.1 The winner, the second and the third placed archers in each category of the European Junior Cup Circuit are determined among the EMAU athletes and teams by the highest total score of two Qualification round results. Out of three Qualification round results only result of the Final leg and one highest will be added, (*i.e., the winner, the 2nd and 3 places will be determined among participants of the Final leg*).

5.2 Determining the winners in competition between EMAU Member Associations

5.2.1 The placement of each MA in the Team Olympic round in each class and division will be taken into account in the calculation. For each MA and each category, the number of points from the Final and the highest number of points in one of the two initial Cups will be added. Each time a MA is classified in the first four places it will gain points in accordance with following table:

	0
1 st place	10 points
2 nd place	8 points
3 rd place	4 points
4 th place	2 points

- 5.2.2 In the case of a tie, the highest number of first places, second places etc. will decide the winner. If there is still a tie, the highest team score in the Qualification Round of the Final of the Cup, whatever category, will determine the winner.
- 5.3. The medals for the final ranking of European Junior Cup circuit for the top 3 individuals in each category will be provided by EMAU.
- 5.4 The cups for the final ranking of European Junior Cup circuit for the top 3 MAs will be provided by the host organizing committee.
- 5.5 The medals and cups are to be engraved by the Organiser with the name and the year of the competition and the place (*e.g.* "EUROPEAN JUNIOR CUP $200X 1^{st}$ place/ 2^{nd} place/ 3^{rd} place").

6 Technical Officials

- 6.1 EMAU Council will appoint a Technical Delegate and two (2) International Judges for each tournament.
- 6.2 The organizing MA will provide at least 7 Judges and a Director of Shooting who have not lower than National Judge status. The organizing MA may invite Judges from other MAs.
- 6.3 The Jury of Appeal will be appointed on the field by the Technical Delegate: a chairman and 2 members as well as 2 alternates.
- 6.4 In addition to the Technical Delegate the attendance by one member of the Committee at each leg is important to maintain the standards of the development of young archers.

7 Entry fee and accommodation

- 7.1 The Organizing Committee will offer sufficient number of rooms. The price should be done not more than **EURO 65** (or equivalent) **per person per day** including full board (the price in double rooms).
- 7.2 The Entry Fee should not exceed **EURO 50 per archer.**



7.3 There will be no entry fees for officials and no entry fees for teams.

8 EMAU support for Member Associations

8.1 EMAU MAs which have not participated in any of the European Junior Cup competitions may apply to EMAU for a grant to enable one archer and one coach to compete. The grant will be awarded upon the decision of EMAU Council.

9 Annual awards for team officials

The European Junior Development Committee will elect every year among the team captains/coaches one team captain/coach and will award him/her. The Team Captain/Coach of the year will be awarded at the Final leg with the diploma and a framed photograph with the writing on it:

European Junior Cup Team Captain/Coach of the year 200X

European Junior Cup Competition Rules were ratified by EMAU Council on November 22nd 2008.

EUROPEAN GRAND PRIX REGULATION (valid as per 1 1 2009)

Art. 1 – Definition

- 1. The European Grand Prix is devised to offer to archers and coaches of the federations within EMAU, a unique opportunity to prepare for world-, i.e. FITA-competitions whilst creating its own challenge in order to rank EMAU archers.
- 2. European Grand Prix competitions will be shot according to the FITA Rules.
- 3. The rules that follow apply only to the European Grand Prix and do not apply to the EMAU Outdoor Target Championships held every two years (even years), which will be held in accordance with FITA Rules.
- 4. The annual circuit requires a minimum of 3 outdoor target events. The events will be selected from applications submitted to EMAU Council, who will ensure that at least one of the events host a Compound division. In case that none of the selected events can host both divisions, the Council has the right to request that one of the 3 Federations of that year's G.P. include also Compound division, or otherwise Council can allocate one other Organizer for that year in place of one of the 3 M.A. originally selected, who will host both divisions

Art.2 – Organization

- Only Member Associations of EMAU (EMAU Constitution Art.1.4.1) may submit an application to host a Grand Prix. The application must be received by EMAU General Secretary prior to 31st October in the 2 years preceding the proposed event. (Attachment 1)
- 2. EMAU Council will designate the preferred dates for the Grand Prix events in the subsequent years; these to be planned approximately 4 6 week apart, and avoiding any clash with FITA-(World)-Championships, or EMAU-Championships in all disciplines.
- 3. EMAU Council will allocate the events. Member Associations will be advised of the definitive calendar for the following year by EMAU General Secretary after the Council decision.
- 4. EMAU Council will apply for World Ranking Status (WRS) for each Grand Prix providing that the minimum standard criteria for World Ranking Status set by FITA can be guaranteed.
- 5. EMAU Council will appoint a Technical Delegate for each of the Grand Prix events and request that 2 International EMAU Judges be appointed by the EMAU Judge Committee .

- 6. Neither the Technical Delegate nor the EMAU Chairman of the Tournament Judge Commission should be from the host country.
- 7. A Jury of Appeal will be appointed by the T.D. on the spot: a Chairman and 2 members as well as 2 Alternates.

Art. 3 - Competition

- 1. Each Grand Prix event shall include individual and teams events comprising of a qualification round, followed by the elimination and finals rounds.
- 2. Where an event is for a single division only, i.e. either Recurve or Compound, then the event will be staged over 3 days with an indicative program as follows:

Pre-event: Arrival of teams and registration, official training and Equipment inspection, Team Captains meeting

- Day 1 Qualification round
- Day 2 Elimination and Finals individuals
- Day 3 Team event
- 3. Where an event can accommodate both divisions, i.e. Recurve and Compound, the event will be staged over 4 days as follows:

Pre-event:	Arrival of teams and registration, official training and Equipment
	inspection, Team Captains meeting

- Day 1 & 2 Qualification and elimination individuals
- Day 3 Team event
- Day 4 Finals individuals
- 4. The minimum requirement for the Match-Play alternating format in Individual events: Semi-finals and Medal Matches (according to the FITA Rules)
- 5. All participants in the Grand Prix events are advised that the competition schedule is liable to change and should confirm the actual competition schedule at the Team Captains meeting held prior to the 1st day of competition.

Art. 4 - Participation

- 1. Only teams recognized by their Member Association of EMAU may participate in the Grand Prix.
 - Teams and individuals from outside of EMAU may be invited to participate providing that they are from a Member Association of FITA.
- 2. Each Member Association may enter a maximum of 6 men and 6 women per Division.
- 3. The host country may enter a maximum of 8 men and 8 women per division.
- 4. The Team Captain has to nominate before the start of the qualification round 3 archers for Ranking for the team-event and for participating in team-competition.
- 5. Team-event
 - One Team per Member Association in each division is permitted, i.e. 1 men's team and 1 women's team, Compound and Recurve .
 - Both teams will start each end of their match with their 3 archers behind the 1 meter line.
 - Only when the Director of Shooting (Judge) starts the match and the time clock the first archer may cross the 1 meter line.

Grand Prix Rules as per 1 1 2009

- In the elimination and Finals Rounds the left/right position of the teams is determined by the match play chart. During the first pairing the team on the top line of each pair will shoot on the left hand side. The actual target assignment for each match is the choice of the organizer
- Byes are allowed.

Note for wheelchair competitors :

In case there is a wheelchair competitor within the team shooting, she/he may be on the shootingline in front of the coachesbox.

During award-ceremonies a wheelchair competitor will be in front of the podium (in front of the corresponding places on the podium).

Art.5 - EMAU Grand Prix Circuit Results

1. Each European archer will be awarded points according to his/her final position achieved in each Grand Prix competition.

The top eight (8) archers belonging to EMAU Member Associations, irrespective of their positions in the final result list, will be awarded points as follows:

1 st place 12	5 th place 5
2 nd place 10	6 th place 4
3 rd place 9	7 th place 3
4 th place 7	8 th place 2
The chore does no	ot offoot the EIT

The above does not affect the FITA World Ranking.

2. The results of each World Ranking Status Grand Prix must be submitted in tabular format to FITA Office by Electronic Mail or Express Mail as soon as the final results are verified. (Within 48 hours after the GP, where a Web Page is not available). Facsimile transmissions are not suitable.

In addition a pdf-format resultlist must be sent to EMAU-Webmaster, see also 6.6.

3. The Organizers must create a Web Site of the event for publishing the daily results.

Art.6 – Responsibilities of the Organizers

- 1. In order to encourage participation in the Grand Prix Circuit the Organizing Committee should limit the expenses for all teams and officials by offering minimal entry fees, transport costs and reasonably priced accommodation. The following will act as a guide:
 - Accommodation: Euro 60 per person per day
 - Entry fees: Euro 100 per person Euro 100 per team
 - Transportation: Hotel to Shooting venue: free of charges . Airport/Station to hotel: minimal charges
 - It is not obligatory to hold a banquet or party at the close of the event. Should the Organizers wish to host such an event Euro 25 per person is advised.
- 2. The Organizers shall arrange and bear the cost for food, lodging and if necessary local transportation for all the Judges.
- 3. The Technical Delegate will advise the Organizers and will check that all preparations are in accordance with FITA and EMAU Rules. The expenses for accommodation of the T.D. will be borne by the Organizers. A preparatory visit of the TD adequately in time before the G.P. approx 3 months is necessary. Also these accommodation expenses will be borne by the Organizers

- Note: Where the Technical Delegate or the Chairman of the Tournament Judge Commission sees a need for additional FITA International Judges to be appointed, a request to EMAU Council and the Judge Liaison Officer should be made.
- 4. All facilities such as accommodation, medical facilities, banking facilities and shops should be within easy access of the shooting venue.
- 5. Fax, telephone and Email connections should be available for all officials and archers at the venue.
- 6. In addition and in line with the quality of the status of European Grand Prix, the following should be offered as standard:

Results at the end of each day. Also accepted in paper form one copy on a notice board and load down the daily results on separate USB-memory-sticks from the Team Captains.

Complete Results at the end of the event – one paper copy with a CD is acceptable – for the Technical Delegate, Judges and Members of the Jury, where these people are not part of a Team.

The organizers must send to the EMAU-Rome-office (<u>media@fitarco-italia.org</u>) for the website a pdf-file with the final results, including tabulatory format (see attachment).

- Encourage sponsorship for the event and for the competitors in the way of prizes either in goods or money
- Encourage media interest, with press accreditation and press facilities.
- Advertisement of official sponsors of EMAU must be displayed on the venue at no extra costs.

Art. 7 – Doping -

The Organizers through its National Archery Federation must arrange for Dopingcontrol, including alchool test. A number of 6 tests is necessary for a Grand Prix.

Please note the word "Grand Prix" is strictly reserved for competitions that count for the World Ranking Circuit, that are proposed to FITA by EMAU.

Unless specified otherwise in this document, FITA Rules will apply. See also the contents of the Organiser Agreement.
