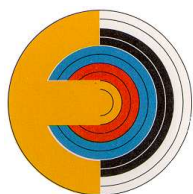
Furthermore, you can submit to the Congress motions about the EMAU Constitution and some modifications of the Rules.

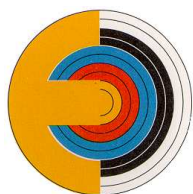

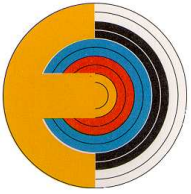

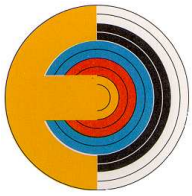
