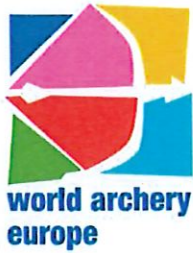

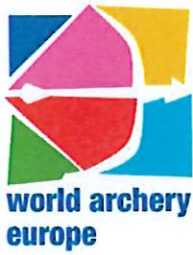

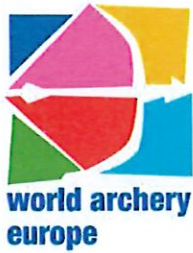

5. Text of the motion	European Club Team Cup – we suggest that the competition, which was established by the Executive board and was run very successful for several years, become a regular competition in the WAE rules and the WAE calendar.
6. Reason	<p>Although the EB decided to cancel the competition, there is still a great interest between the clubs which were regular participating. This is clear evidence, that prize money is not the motivation, but the competition itself. As the WA introduces the new format of the international calendar, there should not be a problem to place the competition into the calendar, as many clubs around the Europe told in the past, that there is a problem that WA, WAE and national calendars are often crossed or too late published.</p> <p>We believe, if WAE approve this competition and implement as a part of WAE rules, plan the WAE calendar as blocks for a year in advance as it was introduced by the WA, that there will</p>

	<p>be more interest for this competition than ever before. As it is written above, the prize money is obviously not the main motivation and this prize awards could be substituted by cups for the best three teams, provided by the organizers. If WAE congress approves our motion, we are prepared to help to update the competition rules, write them more understandable for the organizers and new participants and provide the technical delegate to assist to the organizers.</p>
