Dear participants of the Para-Archery World Ranking event and the Final Paralympic Qualification 2021,

Welcome again to Nove Mesto nad Metuji!

We have been honoured to be tasked by WA, WAE and the Czech Archery Association with hosting of such a meaningful and well attended tournament for the last 20 years.

However, preparing and running of WRE and final Paralympic qualification 2021 in the second year of global Covid-19 pandemic is a real challenge in all aspects of the event.

The process of applying for permission to host the event (February – April 2021) and waiting for the resolution (May 4), composing of the Invitation Package, arranging for entrance of participants to the Czech Republic, staffing of organisers, drivers, volunteers, services, constant following the pandemic situation and measures which change every week made LOC quite tired still before an opening of the tournament.

It has been almost impossible to find someone who would guide us through the paragraphs of all protective measures. Even at authorities that determine them.

All of it persuades me again and again that our event for almost 500 people from 50 countries is a unique project!

I wish to all of you the best sports performance, I wish the best of you can qualify to Paralympics in Tokyo 2021 and I wish to our tournament not to become famous through any „novomestska“ Covid-19 mutation!

3.2 Practice

- Both fields will be used for the competition some days.
- A schedule for free practice will be published with time; Fields will be open for people still involved in the competition.
- To avoid too many people at the same time on the practice field (Field 2) the free practice will be organized by groups:
 - G 1: KAZ–KOR–MGL–POL–RUS1(CWO, W1M, W1W)–SLO–USA
 - G 2: ALB–AUT–CAN–GRE–IRI–ITA–JPN–LAT–MAS–MEX–POR–ROU
 - G 3: ALG–AUS–AZE–BRA–CYP–CZE–ESP–FIN–FRA–GBR–INA–IND–IRQ–NOR
 - G 4: BEL–HUN–IRL–ISL–LTU–NED–RUS2(RMO,RWO,CMO)–SRB–SVK–SWE–THA–TUR–UKR

Official Practice:

- Refer to online schedule

Qualification round practice:

- 3 ends of 4 minutes practice on the Field of Play for qualification to immediately follow once the field is reset.

3.3 Equipment inspection:

- July 5th during official practice.
- Located between the 2 fields of play.
- Teams will be announced in (English) alphabetical order by the DOS.
- All teams are to wear their team uniform and have their valid accreditation.
- Spare equipment must also be brought for inspection.
- Classification card must be presented during the inspection.
- Team managers must check the details of their athletes such as, name, date of birth are correct beforehand.
- Inform the Judge if details are not correct and the Judge will inform Results Team.
- Instructions to use the tablet scoring system will be carried out if requested.

3.4 Athlete (back) Numbers:

- Athlete numbers will be issued on the day of the qualification round (with the score cards) during practice.
- Athlete numbers must be worn on the quiver or thigh, facing the waiting line while shooting.

3.5 Qualification round

- Refer to online schedule.

3.6 Individual elimination round

- Target faces will **NOT** be changed after practice arrows. Please instruct your athletes and assistants to mark all arrow holes during practice.
- Matches will start as soon as the field is ready.
- Matches at the start of each session will begin on time. Proceeding matches will follow up on the immediate completion of the prior match. Athletes should be alert and prepared for their matches to start slightly earlier than scheduled.
- In case of a bye, athletes may be allowed to shoot on their own target, provided the competition schedule allows. If the competition schedule allows, no score will be recorded or displayed and athletes shooting their bye must respect the DOS timing and signals of the competition. Recurve athletes are permitted to shoot 3 sets of practice and compound athletes are permitted to shoot 5 ends of practice for their bye.
- There will be no alternate shooting during the preliminary elimination rounds.

3.7 VI Category

Based on the number of participants registered at preliminary entries, WA Rule 21.12.1. will apply: *"If there are insufficient final entries in either or both divisions, **a single competition combining all VI athletes will proceed with all VI athletes wearing a blindfold regardless of their respective classification.**"*

The schedule has been updated to be shorter and to avoid too many days with no shooting for VI.

Their medal matches will be filmed and broadcast on the same day as the live matches, during the break at the venue.

3.8 Team and mixed team elimination round

- The unusual situation with the European QT and Final QT made impossible to keep all events for the WRE. Priority has been given to QT and preparation for Tokyo.
- The 3 archers team event is withdrawn.
- Only mixed teams event is maintained.

3.9 Appeal procedure (Form attached)

- An Appeal form is attached to this document (see attached after this chapter, Appendix 1).
- In case of an intent to appeal or an actual appeal, the times indicated on the Appeal form must be considered.
- Appeal forms should be given to the Chairman of the Tournament Judge Commission or to their deputy.
- A fee of US\$50- (Euro 50.-) must be paid to the Chairman of the Tournament Judge Commission, for the appeal to be valid.
- If the appeal is upheld by the Jury of Appeal, the fee will be returned. In the case of the appeal being rejected, the fee will not be returned.

4 Technical matters (TD + CoJ)

4.1 Missing arrows

- All missing arrows on the practice or qualification field must be reported to the Judges and Field Crew immediately.

4.2 Timing control system

- ARCHERYCLOCK system will be used for timing on the main field.

4.3 Results system

- Qualification Round - scoring will be completed by athletes or assistants. One athlete/assistant records, on the official paper-based score sheet, the scores of all other athletes on that target. At the same time, another athlete, on that same target, will enter all

- the scores of the athletes on that target into the scoring tablet. The other athletes should verify that all scores are written and entered correctly.
- Scorecards **MUST** be signed by both the athlete and the scorer, have all the totals mathematically correct with the 10s+Xs and X count fully completed. Any scorecards where the 10s+Xs and X count are not completed a “0” will be given for the total of 10s+Xs and X count for that athlete. Any score cards not signed or the score total is missing will result in disqualification.
 - Elimination Round – scoring will be completed by athletes/assistants. One athlete/team records the arrow values of both athletes/teams on the paper score sheet. While at the same time, the other athlete/team inputs the arrow values into the scoring tablet. Both athletes/teams should verify that all scores are written and entered correctly before returning back to the shooting line.
 - At the end of the match, the scorecard must be fully completed and signed by the athletes (or agent/judge in the case of finals) involved in the match.
 - Scoring tablets will be used during the Qualification and Elimination Rounds, but not in the Finals. Mr. Matteo PISANI (World Archery Results & Technology Manager) is responsible for the results of the event.
 - **IMPORTANT NOTE: There will be internet access in hotels. Because of this we will not distribute any printed results and information.**
There will have to be “Pigeon boxes” for teams at the venue to collect selfreporting forms and other mainly sanitary and public health protective measures. TM are obliged to check the mail boxes at least twice a day (morning/ afternoon).

5 Rules that apply in this event

5.1 The rankings

- The Para World Rankings (<https://worldarchery.org/world-ranking>) are updated every two weeks.

5.2 Dress regulations

- Athletes, officials and staff should wear the appropriate clothing having the correct appearance when on the field during competition. Open-toed shoes or camouflage clothing, accessories or archery equipment are not permitted.
- Athletes, team officials and technicians should wear their national team uniforms and sports shoes having the same appearance as per the division, following World Archery rules.
- During finals with TV coverage, undershirts, compression shirts or sleeves may be used on condition that they match the team uniform colours or are white. Under shirts and sleeve may include design, names or markings but the predominant colour should be white or the colour of the uniform.
- We would like to remind all teams that athlete names and country names or codes are mandatory on the back of their national team uniform shirts for athletes participating in World Archery major events.

5.3 Accreditation cards rules

Rule Book 2 – 3.8 Accreditation

- 3.8.1.1. Proof of accreditation shall be carried at all times on the competition area and shall be shown on request of appropriate officials.
- 3.8.1.2. Only holders of appropriate accreditation shall be allowed onto the relevant parts of the competition area.

Accreditation card:

- Athletes and team officials, registered in WAREOS, will be issued an accreditation and lanyard. Please ensure all details are correctly entered in WAREOS. Due to a pandemic situation and Protective Measures there will be no entry to the venue allowed to any person without official accreditation starting with Sunday July 4, 12:00 pm (noon).
- Accreditation will be done by IANSEO and LOC using WA database during Saturday July 3 and Sunday July 4 morning. TMs will check at IANSEO designated tent accreditation cards for their team and will cooperate with IANSEO if there for example are data and/ or photo missing and/ or incorrect.

6 Logistical aspects (OC)

6.1 Transportation

Based on the WAREOS registration LOC will arrange for local transportation for the teams flying to the PRG international Airport and paying to LOC for such a service. Then there are either teams with their own local transport (private cars, rented minivans, buses) or teams ordering local transport from LOC.

Participants that fly to PRG International Airport will be met by either LOC driver/ volunteer at the arrival gate according to the flight itinerary and will be driven to hotel/ venue (arrivals until July 2); Participants arriving on July 3 will be met by LOC volunteers at Welcome Desk at Terminal 2 and either directly driven to hotel/ venue or will be asked to wait until next bus/ minivan is available for them. There will be refreshment at the Desk.

Teams that ordered LOC local transport refer to Mr. Matej SPRAVKA, LOC transport coordinator, on a daily basis to arrange for local transport (hotel – venue) according to a schedule.

6.2 Accommodation

Teams will be lodged in 20 hotels. Due to a pandemic situation and specifics that occur due to lockdown of accommodation and restaurants services for over a year with a release just a month ago this is even more challenging than in previous years. LOC advises to participants to bring narrow wheelchair and/ or crutches if their medical state and ability allow it.

Be aware that there are accessible toilettes and accessible showers at the venue available

anytime.

Some of the teams are lodged in Spa Resort in Kudowa Zdroj in Poland. Crossing the border for the participants of the tournament is agreed by the both guards as it is considered an officially approved project within the European Union and Schengen territory and should be a smooth. However participants are recommended to have their passports, accreditation cards eventually the LOC Information Package (Permission to enter the Czech Republic for non EU countries) ready whenever they might be asked to prove so.

Important parts of the Protective Measures under which our tournament was allowed to let is considering the event a “bubble system”: Venue – hotel – venue. It is evident that visiting restaurants/ shops/ holidays attractions etc. might irritate local authorities and lead to an individual complication, maybe affecting the whole tournament. LOC will not be able to control everyone in all the hotels; therefore LOC leans on a professional attitude and wisdom of each participant.

6.3 Meals during the event

There will be designated space for collecting and consuming of lunch boxes in smaller groups/ tents inside the venue. The meal boxes should be collected by one person from each team to avoid queues and trespassing the protective distance. The groups will be sharing dining rooms with protective measures such as:

- Each entry will have sanitizers.
- 1,5 - meter distance between the tables.
- All the tables will be sanitized after each use.
- After Each meal period the entire venue will be sterilized.
- There will be buffet service, but no self-service. Staff will serve from the backside.
- To avoid long queues, there will be assigned staff to educate guests and ensure that everyone adhere the precautionary measures.
- Regarding the buffet queuing, Minimum 2 m social distancing should be maintained while queuing for buffet which will be indicated with floor markings.
- There will be a schedule for the meals to avoid congestion.

Cafeteria and buffet will be open during the tournament to purchase refreshment; however measures such as minimum square space of 10m² per person and at least 1,5m distance in a queue, wearing masks, regular disinfection etc. should be met.

Cafeteria and buffet accept only Czech currency (CZK); there are ATM or exchange office at the airport upon arrival and ATMs eventually exchange office in Komenskeho street in Nove Mesto (Komerčni banka, CSOB, Ceska sporitelna).

6.3 Water:

Each participant will receive his/ her personal plastic bottle as a souvenir and will draft fresh water from designated pipes himself/ herself.

6.4 Non-Smoking

This is a non-smoking event.

Smoking is forbidden inside public buildings and all competition and training areas. This also includes electronic cigarettes, refer to book 3, Art.12.8.

6.5 The environment

Team managers, please instruct your team members to use the litter bins located on the competition, practice ranges and common areas at all times. Sanitary risky waste (masks, knife&fork, napkins etc.) should be thrown into blue plastic bags.

7 Impact of COVID-19

7.1 Local sanitary measures and regulation

Be aware that despite most of the countries received LOC Invitation Letter and NSA Permission to enter the Czech Republic all participants coming from abroad still must fill in the Arrival Form on: [Příjezdový formulář / Public Health Passenger Locator Form \(uzis.cz\)](#)

All participants (archer, staff, officials, volunteers, ...) must follow WA and local rules and regulation.

All updated information on this matter will be published online (same link as for results and schedule)

BECAUSE HEALTH IS ONE OF THE MAIN PRIORITIES, WE WILL BE STRAIGHT WITH THE RESPECT OF MEASURES.

- If someone (archer or staff member) breaks the rules, there will be a warning
- If the same person breaks the rules one more time, we will withdraw the accreditation and we will refer this person to the WA Board of Justice

The Czech Government has authorized the event to be with the following binding health-antiepidemic conditions:

- The organiser ensures a filter at the entrance to the venue of the sports event (measuring of temperature, collection of selfreporting forms) for all persons that will be entering the venue during the event. Person who will not fill in the selfreporting form and/ or is having

temperature higher than 37,5 °C will be allowed to enter the venue only after consulting a physician appointed by organiser.

- To all persons present at the venue during the event it is imposed to confirm lack of clinical symptoms of infectious disease through selfreporting form. These forms will be available for proposed control by institutions for public health protection at an appointed physician as for the athletes and at an appointed person in case of other persons present at the venue during the event.
- All athletes, team members and all other present people (for next „oblidged“ person) must undergo a screening for virus SARS-CoV-2 by RT-PCR method before the sports event. Result of the screening must be available before the „oblidged“ person enters the venue and must not be older than 7 days. from taking of biological samples. Such a mandatory does not apply to „oblidged“ persons who verifiably went through the disease COVID-19 and at the same time are having no clinical symptoms of COVID-19; further persons who underwent an isolation due to a positive RT-PCR screening for COVID-19 in a range given by the Extraordinary measures of the Ministry of Health within 90 days from the first positive RT-PCR screening.
- In a case that the „oblidged“ person being tested for SARS-CoV-2 virus by RT-PCR method has a positive result and such a person verifiably went through the disease COVID-19 with a prescribed isolation due to a positive PCR screening according to the Extraordinary measures of the Ministry of Health, then such a person can participate in the event only if it is less than 180 days from the first positive RT-PCR screening and at the same time having no clinical symptoms of the disease COVID-19. In case that it is more than 180 days from the first positive RT-PCR testing, such a person will not participate in the event and will be isolated until local insitution for public health protection desides about further proces.
- The „oblidged“ person must undergo RT-PCR screening for virus SARS-CoV-2 or antigen screening for antigen virus SARS-CoV-2 during the sports event. Such screening will be taken on the 3rd and on the 7th day of the event. The person will be isolated from other people in case of positive result and organiser will proceed in accordance with orders of local institution for public health protection.
- Appointed person will record a date and a result of the last RT-PCR test eventually the result of the last antigen test into the selfreporting form.
- Organiser will ensure and will impose wearing of masks at the venue during the whole event. This duty does not apply to athletes nor to judges during the shooting, nor when taking a shower. Respirators of minimum class FFP2 or KN95 **without exhaust valve** will be used.
- Organiser will ensure that the maximum number of people at the venue during the event will not exceed 500 persons.
- Organiser will ensure no spectators in stands during the event.
- Organiser will arrange for suitable place and conditions for proposed preliminary isolation case of appearance of suspicion of infectious respiratory disease.

- Transportation, accommodation and catering will be arranged separately in accordance with valid measures.
- Organiser will keep close communication and co-operation with local institution for public health protection.

The sports event will be run in accordance with the above mentioned binding health-antiepideemic conditions and rules for hosting of sports events in time of pandemia of COVID-19 disease that are issued by the National Sports Agency.

7.2 Entering the venue

There will be two entrance filters for everyone to get to the venue. Volunteers and medical persons will check identity of each person (passport until July 4, accreditation card afterwards), they will measure body temperature and will collect selfreporting forms. The forms will always be distributed to TM (mail boxes) one day advance to be prepared overnight (personal data etc.) for quicker processing the next day.

In case of body temperature higher than 37,5 °C, sickness, bad feeling and whatever illness symptoms such a person will be isolated temporarily in a tent nearby the filter further acting will be discussed with authorised medical person. It may happen that some of the Covid-19 symptoms can appear also in case of non-covid medical problems; it would be helpful if such a diagnosis could be proven by the medical report in english issued by a physician of affected participant.

7.3 PCR Test during the competition

- The LOC will organize tests for all participants on 2nd July, 09:00 – 14:00 PCR for early arriving teams, organisers and volunteers; this is to abide by the measure of maximum 48 hrs from PCR test before start of the event. Early arriving teams will have to pay for such a test another 60,- EUR.
 - 6th July, 08:00 – 12:00 and 13:00 – 15:00 antigen for all participants
 - 10th July, 08:00 – 13:00 PCR for all participants
- The cost for the test is 10,00 Euros for Antigenic + 60, 00 Euros for PCR per person
- Results will take 24 hours maximum.
- Requirement for the PCR test:
 - Official accreditation
 - Passport


