INFORMATION ON COVID-19 RESTRICTIONS DURING THE EUROPEAN INDOOR CHAMPIONSHIP LAŠKO, 14TH – 19TH FEBRUARY 2022

Following is an overview of the measures in place before and during the competition to prevent Covid-19 infections and spreading. The measures are set by the local Government and the National Institute of Public Health.

BEFORE THE COMPETITION

We advise all participants to check their health status proactively and regularly (including taking their temperature and monitoring for any symptoms) before and during the competition. Anyone due to participate in the event who is feeling ill should not attend.

ENTERING SLOVENIA

It is necessary to comply with the RVT condition (R-recovered, V-vaccinated, T-tested) with these specifications:

1. Vaccination

The vaccination condition is met if a person was vaccinated against COVID-19 with a second dose and no more than 270 days have passed since the second dose of one of the following vaccines:

- Comirnaty by BioNTech/Pfizer,
- Spikevax (COVID-19 Vaccine) by Moderna,
- Sputnik V by Russia's Gamaleya National Centre of Epidemiology and Microbiology,
- CoronaVac by Sinovac Biotech,
- COVID-19 Vaccine by Sinopharm,
- Vaxzevria (COVID-19 Vaccine) by AstraZeneca,
- Covishield by Serum Institute of India/AstraZeneca,
- Covaxin by Bharat Biotech (India),
- or a combination of two of the aforementioned vaccines,

or

- one dose of COVID-19 Vaccine Janssen by Johnson and Johnson/Janssen-Cilag and no more than 270 days have passed since the dose.

2. Recovery

Recovery is demonstrated by:

- a positive PCR test result that is older than 10 days and not older than 180 days (6 months),
- a certificate of recovery (positive PCR test result) and vaccination with at least one dose of vaccine received within 180 days from the positive PCR test result, or
- a certificate of recovery (positive PCR test result), vaccination with at least one dose of vaccine received within 180 days from the positive PCR test result and vaccination with a booster dose.

Validity of the COVID certificate:

- **A certificate of vaccination** expires 270 days after the receipt of the second dose. The validity of the certificate is extended if a person receives a booster dose within 270 days of the basic vaccination scheme. The relevant arrangement only applies for people above the age of 18.
- **The validity of the certificate of recovery** is 180 days from the positive PCR test result. If the recovered person is vaccinated, the validity of the certificate is extended by 270 days.

3. Testing

To comply with the test condition, **a negative result is required:**

- **a PCR test** that is not older than 48 hours from the time when the swab was taken, or
- **a HAG test (rapid antigen test)** that is not older than 24 hours from the time when the swab was taken.

The PCR and HAG tests are suitable if carried out in an EU Member State or a Member State of the Schengen Area, Australia, Bosnia and Herzegovina, Israel, Turkey, Canada, New Zealand, Russia, Serbia, the United Kingdom of Great Britain and Northern Ireland or the United States of America.

If a test is carried out in a country not mentioned above, the test is suitable if it also meets all of the following conditions:

- **consists of at least an identical selection of data as the PCR or HAG test** issued in an EU Member State or a Member State of the Schengen Area: forename, surname, unambiguous natural person identifier (PIN, health insurance number, travel document number or another national document number, date of birth or another similar identifier), data on the test type (manufacturer, date and time of the test sample collection), data on the certificate issuer and issue date of the certificate, and
- **is equipped with a QR code**, and
- **enables verification** of authenticity, validity and completeness of the certificate.

DURING THE COMPETITION

During the competition the RVT condition must be observed by all participants.

1. VACCINATION – same rules as with border crossing
2. RECOVERY – same rules as with border crossing
3. For people who do not meet the recovered or vaccinated condition, we will organise rapid tests **every 24hours**.

Testing will take place in the Thermana Hotel every morning, the schedule for that will be published before the start of the competition.

The price of each Rapid Antigen Test is 10 EUR.

In order to organise the rapid testing more easily, we ask all Team Managers to inform us how many people in their teams do not meet the RV condition and therefore need to be tested daily. Please let us know by 7th February via this email address:

In the attachment you will find a form about the RVT condition of the teams, which the Team Manager must fill out, and bring it upon arrival to the accreditations desk in the hotel. For checking the validity of the information, each participant must bring proof of meeting the RVT condition and an ID card.

IN CASE OF INFECTION

Despite all precautions it is possible that a participant could get infected.

If a person has no symptoms but tests positive or if a person starts exhibiting symptoms of infection which is then confirmed with a positive test result, they will have to go into isolation. Isolation lasts at minimum for 7 days and ends if after 7 days the person doesn't show symptoms for 24 hours or tests negative on an HAG test.

The Local Organizing Committee is not responsible for any cost resulting from positive cases such as changing flight or hotel accommodation, or isolation.

However, the organiser will make it possible to stay in isolation in a separate part of the Thermana Hotel or in another hotel, where the person will be staying in one room and the food will be delivered to their door. In case of a prolonged stay a discount will be possible.

We recommend that prior to leaving for competition you arrange a special travel insurance – in case you need to change your return flight, find new transport and/or stay in the hotel longer because of mandatory isolation.

MASKS

Surgical mask or FFP masks (not textile ones) are mandatory:

- in all closed public spaces,
- on public transport,
- in open public spaces or outside, if a distance of at least 1,5 metres is not maintained and
- in personal vehicles.

Masks are not compulsory for:

- persons practicing sports,
- guests (subject to the RVT rule) in enclosed public places and places where food and drink is prepared and served,
- speakers in enclosed public places or premises if a distance of at least 3 metres from others is maintained,

That means that archers will have to wear a mask during the competition, except when they are on the shooting line. Masks are to be worn in the hotel at all times, except when sitting down at the table in the restaurant.

OTHER MEASURES

To prevent infections, we encourage all participants to wash and disinfect their hands regularly and to maintain a social distance of at least 2 meters.





DEPARTURES

We kindly ask participants to inform us by 7th of February if they require HAG or PCR testing for their travels home. We will organise them for the last day of competition.

The price of the HAG test: 10,00 EUR

The price of the PCR test: 95,00 EUR

Invoices will be issued; payment in cash or bank transfer.

GENERAL INFORMATION ABOUT ARRIVALS AND ACCOMODATIONS

- upon arrival to Laško please come to the accreditations desk in the lobby of the Thermana Hotel
- after checking the RVT conditions of the team, the Team Manager will check entries and payments and then you can do check-in at the hotel front desk
- the room rate includes full board (all meals included), which means:
 - if you begin with lunch, your last meal is breakfast
 - if you begin with dinner, your last meal is lunch

We ask those who have self-arranged transport to send us information on whether you will be starting with lunch or dinner on this e-mail address: oc-lasko@archery-si.org.

In case of late arrival (dinner is served until 9PM), we can provide you with a cold dinner. Please notify us via sms or WhatsApp message on +386 31 633 851 (Mrs Irena Rosa). The same goes for early departures: we can arrange a to-go lunch packet.

This way you will confirm all entries and we will be able to provide you with accreditations for official practice on Monday, a start list and start numbers.
